What is Airspace Change?

In 2017 Government instructed the UK's independent aviation regulator, the Civil Aviation Authority (CAA) to develop a strategy to modernise the UK's airspace.

The structure of the UK's airspace has remained the same for decades, but like our roads and rail infrastructure on the ground, we need to keep our infrastructure in the sky up to date to keep people moving. The CAA's Airspace Modernisation Strategy was published in December 2018 and outlines the work that needs to happen to modernise airspace, and why.

At Bristol Airport we fully support the objectives of this initiative to make journeys quicker, quieter and cleaner.

In October 2018, Bristol Airport submitted a Statement of Need which can be found on the CAA's Airspace Change portal setting out our intention to make changes to the airspace impacting departure and arrival procedures.

Why your input is important

Central to the Airspace Change process is continued engagement with local communities and as a representative in an area that may have an interest in our Airspace Change, Bristol Airport would like to invite you to participate in an Airspace Change workshop.
