Sorry for the belated answer.

I don't represent an airport or organisation. I'm only expressing my views as a glider pilot based in Gloucestershire.

Please consider the following as my comments:

I object to the proposed airspace change.

While I normally call Rissington Radio while close, I feel the ACP is disproportionate, not properly justified and will not provide an overall benefit of the UK aviation community.

I seems disproportionate for an airfield with 5 based aircraft and a very small number of visitors to be given an ATZ. On that basis nearly all airfield and half of the farm strips would qualified if they could use taxpayer money to provide AGCS.

The 2 airproxes quoted in section 3 are not relevant to the proposed ATZ. The 2018 Airprox (2018269) was classified as Risk Category E by the Airprox Board, that is "normal procedures, safety standards and parameters pertained". The 2019 Airprox (2019079) occured above the proposed ATZ.

In view of the absence of relevance of the Airprox quoted in the consulation document, I feel the relevance of the 40 DASOR quoted in section 3 is put in question.

The consultation document reproduce some of the military half and quarter million maps. Has the sponsor investigated changing the depiction of Little Rissington airfield on the civilian maps? It would be benificial to be charted as a gliding site with a large "G" rather than as a government airfield with gliding activity (only a little G on the periphery).

The consultation document does not discuss the impact of the proposed airspace sponsored by RAF Brize Norton. The combination of these 2 ACP is going to transform the area to the south of Little Rissing into a dangerous pinch point.
