- design shall provide a Flight Plan Buffer Zone (FBZ) for the purposes of Free Route Operations and flight planning.'
- They also stressed that DP (k) 'Protocols for the prioritisation of area activation shall be established to minimise the accumulative overall effect of Defence airspace needs on other airspace users' was required to manage the network. The Change Sponsor said they would accepted both DPs, and will incorporate in ACP-2020-092 moving forward and added DP (k) especially made sense given the amount of exercises the MoD conducts that have a requirement for airspace.
