Update on Glasgow Airport's airspace change proposal

I am emailing on behalf of Glasgow Airport with regard to its airspace change proposal (ACP). As you may be aware, we had been in the process of seeking a broad range of stakeholders' views on the way in which Glasgow Airport should progress its part of a UK-wide initiative to modernise the country's airspace, known as the Airspace Modernisation Strategy (AMS). However, given the outbreak of COVID-19, Glasgow Airport took the decision in 2020 to postpone this work.

The airspace modernisation programme represents the biggest change in how the industry manages its airspace in over 50 years. It will enable us to better manage the airspace around the airport, without compromising on safety, delivering a number of potential benefits such as environmental improvements, noise management and minimising the amount of time aircraft queue, both in the air and on the ground.

For your reference in the coming months, we will be looking to restart our engagement activity regarding our airspace change proposal. Glasgow Airport is committed to engaging stakeholders as part of this process. As well as engaging with the Civil Aviation Authority (CAA), National Air Traffic Service (NATS), and the UK Department for Transport (DfT), we will be continuing to seek views from our local and regional stakeholders.

As we move forward given your role in the community, we would be keen to provide you with a briefing on the next stage of the airspace change process. We will be in contact in due course to arrange such a meeting with the project team. I am emailing on behalf of Glasgow Airport with regard to its airspace change proposal (ACP). As you may be aware, we had been in the process of seeking a broad range of stakeholders' views on the way in which Glasgow Airport should progress its part of a UK-wide initiative to modernise the country's airspace, known as the Airspace Modernisation Strategy (AMS). However, given the outbreak of COVID-19, Glasgow Airport took the decision in 2020 to postpone this work.

The airspace modernisation programme represents the biggest change in how the industry manages its airspace in over 50 years. It will enable us to better manage the airspace around the airport, without compromising on safety, delivering a number of potential benefits such as environmental improvements, noise management and minimising the amount of time aircraft queue, both in the air and on the ground.

For your reference in the coming months, we will be looking to restart our engagement activity regarding our airspace change proposal. Glasgow Airport is committed to engaging stakeholders as part of this process. As well as engaging with the Civil Aviation Authority (CAA), National Air Traffic Service (NATS), and the UK Department for Transport (DfT), we will be continuing to seek views from our local and regional stakeholders.


