## 1. Introduction – CAA to open

## 2. Statement of Need (discussion & review)

The change sponsor, in conjunction with the Northumbria Healthcare NHS Foundation Trust and utilising the government funded Small Business Research Initiative (SBRI), is looking to conduct feasibility trials using uncrewed air vehicles (UAVs) between hospitals in Northumbria for the distribution of medical payloads such as chemotherapy drugs and urgent medical supplies and samples.

The change sponsor is proposing an evaluation of the potential advantages of transporting such time sensitive small and medium-weight healthcare items by use of UAS Beyond Visual Line of Sight (BVLOS) delivery operations during the *autumn of 2022\**.

In order to do this in the area selected for this activity, current regulation requires the activity to be contained within segregated airspace.

Altitudes affected: Sea level to 1400ft amsl





## 2. Statement of Need - Chemotherapy + blood samples

#### **Locations**

- 1. Wansbeck General Hospital, Ashington
- 2. Alnwick Infirmary (Wed + Fri)
- Berwick Infirmary (Wed + Thurs)

### Up to 20 patients per day

#### **Outcomes to be measured**

- Faster delivery
- Greener delivery
- Access to care





## 3. Issues or opportunities arising from proposed change

**Issues:** 

- Other ACP in region Offshore Renewable Energy <u>ACP-2021-089</u> (paused), any others?
- Electric Conspicuity Use of SSR and ADS-B (SSR for Newcastle Airport) EC CAP 1391.
- <u>CAA Buffer Policy</u> we wish to have a dispensation on the 3nm from Controlled Airspace requirement. Discussions with Newcastle ATC.
- **OA and ACP alignment** Need to ensure alignment of OA request, ensuring it can be issued alongside the TDA process.
- **Multiple drone operators** Would like to use 2 drone operators due to support the NHS requirements (payload). Would ensure deconfliction plan agreed.
- **Airspace** Should we consider whether a TMZ is more appropriate than a TDA.



## 4. Options to exploit/address issues & opportunities identified

#### **Opportunities**

- Plan for a wider network linking additional sites in the Northumbria and North Cumbria Areas.
- Gain operating experience and airspace use to build knowledge and procedures for later overland routes.
- Roadmap towards operating in central Newcastle (North Tyneside and NSEC) which are under Newcastle Airport's CTR.
- CAA Innovation engagement.
