Executive Summary

This report documents the Consultation Strategy proposal for Stage 3 of ACP-2019-18, to facilitate the operation of the Remotely Piloted Air System (RPAS), Protector RG Mk1, as well as activity required by the RAF Aerobatic Team (RAFAT) in airspace over RAF Waddington, in accordance with the Civil Aviation Publication (CAP) 1616 Airspace Design.

ACP-2019-18 has successfully completed Stage 1 (Define) and Stage 2 (Develop and Assess) of the seven stage process defined by CAP 1616; all supporting documentation can be found on the Civil Airspace Authority (CAA) online portal¹. The requirements for Stage 3A, Consultation Preparation, are as follows:

- 1. Produce a draft Consultation Strategy detailing the scale, nature and timescales of the proposed consultation;
- 2. Produce a draft Consultation Document that allows stakeholders including those with no technical expertise to understand the potential impact of the proposed changes;
- 3. Produce an Options Appraisal (Phase II Full) identifying potential impacts and mapping potentially affected stakeholders.

This document addresses the requirement for (1), the Consultation Strategy.

UK public consultation for ACP-2019-18 will be 12 weeks in duration, iaw CAP 1616.

The Consultation Strategy, as summarised below, is geared toward reaching as many stakeholders as possible, and as early in the consultation process as possible, with regular reminders:

- Prepare a single consultation document, suitable for all stakeholders to understand, interpret and comment upon;
- Consult directly with those aviation and non-aviation stakeholders that have been identified and participated in the initial stakeholder engagement at Stage 1 and 2;
- Consult with the wider local community through engagement with Town and Parish Councils, including those not previously contacted directly;
- Conduct early local press and media promotional engagements;
- Conduct drop-in briefing events;
- Contact members of any stakeholder groups who have not responded after 6 weeks to remind them of the deadline for consultation;
- Review and analyse the consultation responses and complete a Consultation Feedback report.

1 Introduction

1.1 Background

ACP-2019-18 was initiated in 2019 to enable the operation of a large Remotely Piloted Air System (RPAS), Protector RG Mk1, from its main operating base when it comes into service at Royal Air Force (RAF) Waddington from the early-2020s. This requirement remains in place. Owing to the scheduled closure of their current operating base at RAF Scampton, there is also a requirement for the RAF Aerobatic Team (RAFAT) to access airspace over RAF Waddington to conduct flying display activity from early 2023.

The Ministry of Defence (MOD) felt that the best way to manage this new requirement was to combine both the Protector and RAFAT requirements within one airspace change proposal (ACP). The Civil Aviation Authority (CAA) and the MOD agreed a means by which to do so².

The MOD passed the Stage 2 Gateway for ACP-2019-18 on 29 April 2022 and have commenced Stage 3 CONSULT.

1.2 Statement of Need

There is a requirement for a large Remotely Piloted Air System (RPAS) to operate from RAF Waddington from the mid-2020s. Pursuit of an ACP optimises an approach, in terms of efficiency and safety, for RPAS to operate from and to RAF Waddington. Furthermore, this approach will support the safe integration of the RPAS into the national airspace structures, given the anticipated performance of on-board systems and the surrounding airspace classification. Access to existing training areas around the UK will also be considered as part of the integration into the national airspace structures. There is an emerging requirement for the RAF Aerobatic Team to conduct display flying activity over RAF Waddington from early 2023 following the Team's relocation from RAF Scampton in late 2022. Integration of this requirement within the Protector ACP is considered the safest operating model.

2 Consultation preparation and Engagement to date

2.1 CAP 1616 Requirements and Document Scope

The CAA Civil Aviation Publication (CAP) 1616³ provides guidance on the regulatory process for changing the notified airspace design and planned and permanent redistribution of air traffic, and on providing airspace information.

ACP 2019-18 has completed Stage 1 (Define) and Stage 2 (Develop and Assess) with all the supporting documentation uploaded to the CAA ACP Portal⁴. The CAA has confirmed that ACP-2019-18 is a Level 1 change. The requirements for Stage 3A, Consultation Preparation, are as follows:

- Produce a draft Consultation Strategy detailing the scale, nature and timescales of the proposed consultation;
- Produce a draft Consultation Document that allows stakeholders including those with no technical expertise – to understand the potential impact of the proposed changes;
- Produce an Options Appraisal (Phase II Full) identifying potential impacts and mapping potentially affected stakeholders.

This document addresses the requirement for (1), the Consultation Strategy.

The remainder of this section illustrates the engagement activity to date in support of ACP 2019-18. Section 3 catalogues consultation stakeholders with section 4 describing the consultation strategy itself.

Table 2 below summarises the activities undertaken during the most recent phase of engagement (Stage 2 of the ACP process).

Of the 155 identified stakeholders contacted, 32 responded. 24 provided comment on the airspace design options. 7 stakeholders responded with no comment and one requested an update on the timeline for the ACP. Key themes for comment were:

- Impact on airspace users
- Airspace design
- Air Traffic Management
- Safety
- Notification
- Regulation
- Engagement process
- Operation of Protector
- RAF Scampton / EG R313

2.2 Next steps

Using the most up-to-date and credible data available, the consultation documents, including the second-phase full options appraisal, have been developed around the engagement feedback gained as part of Stages 1 and 2 and as greater understanding of RAFAT and Protector operating requirements has been reached. The consultation and supporting materials have been developed to suit a range of audiences. Whilst it is necessary to use some technical terms in order to

adequately describe this airspace change and the issues around it, materials will be as concise and accessible as possible to those without aviation or technical knowledge. The Change Sponsor will make efforts to ensure all respondents understand the issues.

3 Consultation stakeholders

In creating a comprehensive stakeholder list the MOD has considered all who may be impacted (positively, negatively and potentially impacted) as well as those that may just have an awareness or interest in the change proposal. Local communities are expected to see no change to the impact of noise or air pollution. Minimal impact is foreseen for environmental stakeholders with regard to noise, CO₂ emissions and fuel burn, whilst no impact is anticipated on air quality, tranquility and biodiversity. Some impact is anticipated on aviation stakeholders, but this will be minimised by the use of various mitigations. The most impacted aviation stakeholder group is likely to be the gliding community, particularly those operating without radios.

In consulting with a wide range of national and regional organisations, the Change Sponsor is expecting them, as over-arching bodies, to consider the information provided in this consultation material and provide feedback on behalf of their stakeholders or members.

3.1 Non-Aviation Stakeholders

3.1.1 General Public

Consultation with the general public will be conducted by MOD representatives at public drop in sessions at key locations in Waddington and Lincoln. Local press and media will also be utilised to promulgate the consultation with focus on encouraging any individual or organisation to submit a response to the consultation.

3.1.2 Local Area Stakeholders

Local authorities, including county and parish councils that represent communities at the local level, most of whom have already been involved in the Stage 1 and Stage 2 engagement, will be contacted as part of the consultation. This will include those local authorities contacted during the withdrawn RAFAT ACP. A short list (nine in total) of other local area stakeholders has been added to the stakeholder list for Stage 3 following recommendation from RAF Waddington's media team. They include local officers/posts that RAF Waddington frequently inform of local changes at station level. The addition of seven relevant Members of Parliament (MPs) has been made for Stage 3 since RAF Waddington sits adjacent to seven parliamentary constituencies. Direct engagement with the seven MPs will take place. Finally 28 local parish councils have been added to the stakeholder list; the Change Sponsor did not extend the list to parish councils in Stages 1 and 2 with the exception of Waddington Parish Council. The full list of local authorities, other local area stakeholders and MPs can be found in Appendix A.

3.1.3 Environmental Organisations

A selection of environmental organisations were engaged with during Stages 1 and 2. They will be invited to provide feedback to the consultation. A list of these organisations can be found in Appendix A.

3.2 Aviation Stakeholders

Aviation stakeholders have already been identified and invited to provide feedback during Stages 1 and 2. An additional two stakeholders have been added to the list since Stage 2 was completed. The Consultation Communication will be maintained throughout Stage 3 as described in Section 4. Appendix B lists all Aviation stakeholders.

4 Consultation strategy

4.1 Communication approach

The overarching aim of the Change Sponsor is to ensure that all impacted stakeholders are able to suitably participate in consultation. Notification of consultation will be varied in order to reach a maximum number of potentially interested parties (including those without internet access). This broad approach of notification aims to meet the intent of CAP 1616 and the requirement to include seldom-heard groups in consultation. The Change Sponsor has not specifically identified any seldom-heard stakeholder groups, but will use a mixture of methods of communication (online, social media, TV, radio, face-to-face) to maximise reach. Owing to the high profile of RAFAT and current public interest in RPAS activity, it is proposed that the communication process is apportioned into three stages; Launch, Engagement Period and Consultation Reassessment. This will aid in ensuring all aspects of consultation are initiated, monitored for progress and associated timescales are met if a high volume of communication is received.

4.1.1 Launch

The consultation will be launched on Wednesday 7 September 2022 via the CAA ACP Portal. Promulgation of the launch will consist of the following activities:

- Identified Stakeholders. Those listed in Appendices A and B will be notified of the launch via email. A record of communication activity with all stakeholders will be maintained throughout the consultation process.
- Press Release. A formal press release and public promotions will occur 7 13 September to
 include all media covering the area likely to be affected by the proposed changes. Media to be
 utilised are: local papers/publications; local radio; local television; RAF Waddington Facebook
 and Twitter. These will contain information about the consultation via social media; direct
 interested parties to the CAA ACP Portal and the public drop-in events (see 4.1.2.1); provide
 details of how to request and submit information for those without internet access.
- Newspaper and radio coverage will focus on the Lincolnshire area since this is likely to reach the most affected stakeholders. Television coverage will reach further afield due to the television transmission catchment areas of the local television channels. Targeted TV channels will be BBC Look North (East Yorkshire and Lincolnshire) and ITV Calendar (Yorkshire, Lincolnshire, Nottinghamshire and North Derbyshire). Whilst the list of local authorities spans 7 counties, many of these are included in accordance with the agreement to extend the consultation communications with stakeholders from the original RAFAT ACP which has been subsequently withdrawn. There is thought to be little merit in seeking newspaper, television and radio broadcasting further afield than described above.

4.1.2 Engagement Period

Consultation will run for a period of just over 12 weeks commencing 7 September 2022, closing on 30 November 2022. A variety of activities will occur during the engagement period to maintain proactive exchange of information and to maximise positive exposure of the proposal:

4.1.2.1 Public Drop-in Events

Drop-in events will be held in Lincoln and in Waddington in September 2022 to provide an opportunity for individuals wishing to convey feedback or pose queries in person. Hosted by appropriate MOD and non-MOD subject matter experts (SMEs), these sessions will offer an informal opportunity for interested parties to find out more about the proposed airspace change and to leave formal feedback if required. Assistance will also be provided to those who would like help in submitting a response to the consultation via the CAA ACP Portal.

In the event that it is not possible to host the Public Drop-in Events, a virtual consultation will be implemented. Although this will impede the ability for stakeholders unable to access the internet, all media methods will be utilised to mitigate and encourage alternate means of participation, such as postal correspondence or representation through their local Council.

4.1.2.2 Citizen Space

To comply with statutory requirements, the ACP 2019-18 Consultation will be presented on the Citizen Space platform from 7 September 2022. Appropriate information and documents will be available to the public to maintain transparency and accountability and to offer a facility to obtain feedback.

A Feedback Form will be accessible via Citizen Space and will be integral to the feedback process; the template Feedback Form is at Appendix C and will also be uploaded to the CAA ACP Portal.

Frequently Asked Questions (FAQs) will be developed and uploaded to Citizen Space. This will be a living document and evolve as common queries and themes become apparent from the feedback.

4.1.2.3 Postal submissions

Postal feedback can be submitted to the consultation. Additionally, a paper copy of the online Feedback Form will be available on request. Respondents may include a stamped envelope should they require a reply. Postal submissions will be uploaded to the CAA ACP Portal alongside any online responses. Regardless of how the stakeholder responses have been received they will be addressed as part of the ACP. The consultation postal address will be provided online, within the consultation document and also publicised as part of all press release activities.

4.1.2.4 Response Management

Where pertinent, responses that require a reply during the consultation period will be acknowledged via the same method by which they were received. Direct contact with stakeholders/responders will only be made if necessary, by appropriate SMEs.

Categorisation of responses will be in accordance with CAP 1616 Appendix C and uploaded to the CAA ACP Portal.

4.1.2.5 Reminders to stakeholders

To encourage utmost input, those stakeholders listed in Appendices A and B yet to respond will be contacted mid-way through the consultation period. A reminder will also be distributed via social media channels.

4.1.3 Consultation Reassessment

Progress of the consultation will be reassessed week commencing 17 Oct 2022. Evaluation of progress and any consequential adaptations will be established through:

- Feedback received from each of the key stakeholder groups identified in Section 3;
- Evidence of local media publicity (Section 4.1.1);
- Attendance numbers at the public drop-in events (Section 4.1.2.1)
- Analysis of engagement on Citizen Space

Should it be considered that stakeholder engagement has been insufficient, or due to unexpected events affecting response submissions, it may be necessary to extend the Consultation Period and conduct additional events, The CAA will be notified and consulted on any significant deviations from the Consultation Strategy stimulated by consultation reassessment.

4.3 Consultation Documentation

The following documentation will be presented for stakeholders to read:

- Consultation Document. The main document will be uploaded to the CAA ACP Portal and will provide a comprehensive breakdown of the airspace design options as well as background information on the ACP. A paper copy of the Consultation Document will be available on request.
- Frequently Asked Questions (FAQ). An FAQ section will aim to answer both aviation-specific questions as well as address general themes received during previous engagement. This will be a separate document that will be updated as required throughout the consultation period should trends begin to develop with feedback questions. This will be updated via Citizen Space.
- **Full Options Appraisal.** As part of the Stage 3 gateway the Change Sponsor will produce a Full Options Appraisal. This will be available for consultees to read should they wish to obtain more technical detail.

5 Post-consultation and Next Steps

5.1 Collate and review responses

On completion of consultation the Change Sponsor will review all responses and categorise them for analysis. As with previous engagement feedback responses will be categorised into responses directly relating to the ACP and more general feedback that does not.

All original responses will be analysed and sent to the CAA with a redacted version uploaded to the CAA ACP Portal (including raw data).

5.2 Stage 4 – Update and Submit

The Change Sponsor will consider whether, in light of feedback received during consultation, the airspace design options need significant re-design that would warrant further consultation with stakeholders.

Provided additional consultation is not required the Sponsor will begin to draft the final submission to the CAA as part of ACP Stage 4. Table 4 below summarises the next steps after consultation has closed.
