Summary

- 1) The process for the Court hearing re Judicial Review is still ongoing.
- 2) Current ATS provision is required, due to the undertakings, until 2359 2 Dec 22.
- 3) Not certain of extension to ATS provision at this juncture.
- 4) Action - ACP will remain paused until certainty on the provision of an ATS to safely manage the DSA Airspace notified in the AIP.
- 5) Action - ATCSL will issue NOTAMS to safely manage the extant airspace until 2359 2 Dec 22.
- 6) Action - A progress meeting will be held early next week or sooner if information relating to the provision of an ATS is forthcoming.

Summary

- 1) Email received by CAA 28 Nov 22 stating - DSA have informed ATCSL that they will no longer require any air traffic services beyond the current contract which expires at 2359 on Fri 2 Dec 2022.
- 2) NOTAM has been issued stating withdrawal of ATS provision 1800 30 Nov 23.
- 3) ATCSL to be fully withdrawn from DSA 2359 2 Dec 2359 which is aligned with the required undertakings to this point.
- 4) Undertakings not safely achievable beyond this point.
- 5) Action - CAA will administer closure NOTAM from 0001 3 Dec 22.
- 6) The court has yet to publish a decision in relation to the council's application for judicial review.
- 7) Action - ATCSL and DSA will write letters to Manager Aerodromes & ATM requesting the withdrawal of the ATC certificate and the aerodrome licence. Aerodrome licence decision to be made 5 Dec 22.
- 8) Action - ACP will be un-paused on receipt of the ATS letter. The relevant letter and meeting notes will be uploaded to the CAA ACP Portal accordingly.
