- “NERL believe there is a risk of stakeholder confusion during the consultation phase of the process by supporting two very similar ACPs in parallel which are associated with the same proposed change to airspace” – as you outline below this is related to stakeholder confusion of consultation on two changes in the same geographical area
- The paper wasn’t intended to suggest that the current Liverpool ACP is at the pre-Stage 3 gateway stage. As you are aware ACOG are currently working with MTMA ACP sponsors to resolve the misalignment of timelines.

Thank you for the advice and yes we are content with the rationale, and accept the amalgamation of NERL’s MTMA proposals.

We have just a couple of minor points of clarification:

In Para 4 you say “NERL believe there is a risk of stakeholder confusion during the consultation phase of the process by supporting two very similar ACPs in parallel which are associated with the same proposed change to airspace”. Did you mean “associated with the same proposed change to airspace” or was it more associated with two changes in the same geographical area?

Our understanding is that Liverpool is currently paused in Step 4a, not as the letter seems to suggest 'all' are pre-stage 3 gateway. Notwithstanding this, we expect ACOG to continue to co-ordinate with Liverpool to address any issues caused by the current misalignment.

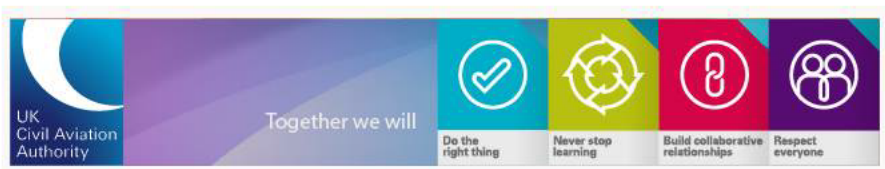
