Airspace Change Proposal ACP-2021-030 (Temporary Danger Area) Approved

Dear Sir/Madam,

We have recently been advised by the Civil Aviation Authority that our proposed Temporary Danger Areas at Radnor, Powys have been approved. During this process we have been incredibly grateful for the engagement of all our Stakeholders in shaping the proposal. We believe the approved TDAs achieve the aims of our initial Statement of Need, whilst mitigating the effects on our local communities.

Please find below a summary of the TDA construct, operating criteria and feedback channels. All further information relating to this ACP can be found on the CAA's Airspace Change Portal (https://airspacechange.caa.co.uk).

TDA Construct

Two concentric TDAs have been established during the period **14 Nov 23 to 12 Feb 24** as below:




Our approval allows for 18 days of planned activity during the 90-day activation period; although we may utilise additional days if operations are curtailed due to weather. The TDA will not be used at weekends.

When the TDA is not NOTAM'd as active, you may assume that the airspace remains as Class G and open to all (notwithstanding the existing ground range restrictions found in Section 5.3 of the UKAIP).

A DAAIS will be provided by London Information on 124.75 for the duration of activities. If planned flying is curtailed or cancelled then London Information will be informed and the airspace will be returned to Class G.
