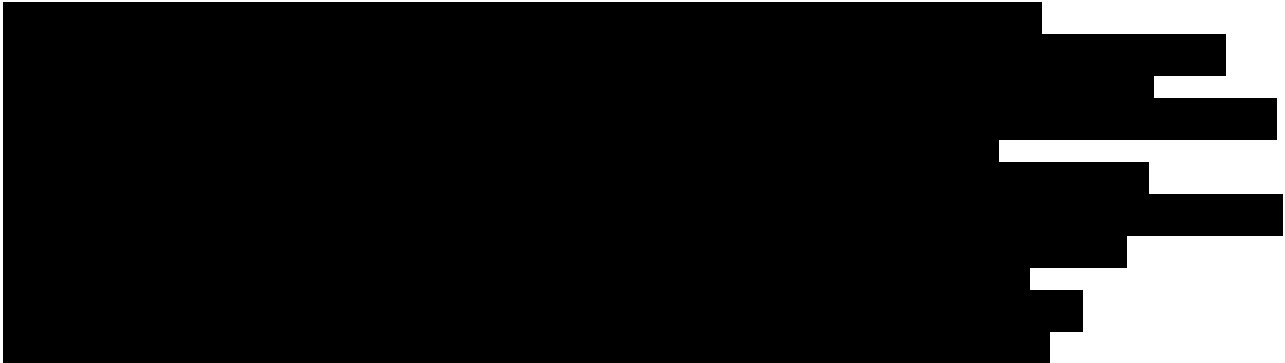

Thank you for your correspondence and all you have done to assist with communicating the proposals of Farnborough Airport.

Please find below my observations and possible changes for your consideration.

## **1. Operations restricted to more modern aircraft, using green aviation fuel.**

Within this Airspace Change Process Farnborough Airport has a Design Principle to “Make best use of Farnborough’s modern aircraft fleet capabilities”. However, CAP 1616 does not require an airspace change to enforce or restrict the type of fuel in use. Nevertheless, Farnborough Airport has a proud history of leading on sustainability, becoming the first airport of its kind to be Carbon Neutral accredited in 2018. We want to be a Global Showcase for Airport Sustainability.

Our ambitions include becoming a 100% Sustainable Aviation Fuel (SAF) airport before 2030, and we want to be a catalyst for change, not just in our core markets, but within the aviation industry more generally.

Since 2018, Farnborough Airport has been carbon neutral for Scope 1 & 2 emission sources. Recently we were awarded Level 4+, the highest level of carbon accreditation, by the Airport Carbon Accreditation (ACA) scheme. The ACA is the only institutionally endorsed, global carbon management certification programme for airports, independently assessing and recognising the efforts of airports to manage and reduce their carbon emissions.

To achieve carbon neutrality the Airport currently uses REGO backed electricity (Renewable Energy Guarantees of Origin) and offsets residual emissions.

We have also committed to being Net Zero for Scopes 1 & 2 emissions sources by 2030 or sooner, which will reduce these emissions by over 90%. This means there will be significantly less reliance on carbon offsetting, although residual emissions will still need to be offset consistent with Net Zero protocols.

The aviation industry is working hard to develop new fuel and aircraft technology in response to the global climate challenge. Aligned with Government targets to achieve Net Zero by 2050, the aviation sector has established its own Net Zero Carbon Road Map, developed by Sustainable Aviation <http://www.sustainableaviation.co.uk>

As a member of Sustainable Aviation, Farnborough Airport is working with stakeholders from across the industry to help tackle the challenge of ensuring a cleaner, quieter, and smarter future for the aviation industry.

## **2. AONB / tranquillity / habitats should be avoided.**

We expect this to be a key consideration and, where applicable, a feature of any public consultation when Farnborough’s proposals are more mature in the next stages of the project. In the meantime, our assessments in this stage of the project will include an assessment of overflight of AONBs, National Parks as well as a Habitats Regulation screening assessment.

We are required to adhere to Air Navigation Guidance which states that “where practicable, it is desirable that airspace routes below 7,000 feet should seek to avoid flying over Areas of Outstanding Natural Beauty (AONB) and National Parks”. It goes on to say “Given the finite amount of airspace available, it will not always be possible to avoid overflying National Parks or AONB, and there are no legislative requirements to do so as this would be impractical. The government’s policy continues to focus on limiting and, where possible, reducing the

number of people in the UK adversely affected by aircraft noise and the impacts on health and quality of life associated with it. As a consequence, this is likely to mean that one of the key principles involved in airspace design will require avoiding over-flight of more densely populated areas below 7,000 feet. However, when airspace changes are being considered, it is important that local circumstances, including community views on specific areas that should be avoided, are taken into account where possible.

### **3. Holding space not below 7,000 ft. where possible.**

Farnborough already has holding stacks, some distance away from the airport above 7000ft and one very rarely used close-in contingency stack at 3000ft. One of the features we aspire to achieve is a new contingency holding stack in a more suitable location, ideally at altitudes higher than this. We are however limited by Heathrow and Gatwick's departure and arrival routes and Controlled Airspace boundaries.

### **4. Where increase in flight numbers and operating times is proposed, consider an extension of compensation for all those areas impacted. And that, compensation should be used appropriately through liaison with Councils and communities.**

I would like to take this opportunity to reiterate that communication is key – It's been encouraging that Farnborough Airport recognises this. I politely request that you continue in this vein, and that you take residents with you rather than they are left feeling they haven't had their voices heard.

Thank you and we will.

In addition, please could you reconfirm you have decided not to pursue any change to the current non-weekend operating times; that you revised annual non-weekend flights – (limits have been proposed to ensure growth is phased over time), that you have new measures, 'to mitigate and reduce the potential for increased aircraft noise'; and that you have planned for additional funding to the Airport's community funding programme, and also for 'the potential for a broader remit in terms of local community initiatives'.

We can confirm these points.

In addition, that you have proposed additional monitoring and reporting on emissions reduction and air quality with aims to adopt 100% Sustainable Aviation Fuel (SAF).

We can also confirm these points, albeit with regards to SAF, this will rely upon its practical availability.

I sincerely hope this response is helpful, and I look forward to receiving confirmation on the points I have asked you to reconfirm above.

The answers to your questions are as follows:

1. Are you able to provide/access this data in a digital drawing format (csv, dwg, kml) so we could plot and understand vertical profiles?

There is no typical flight profile and pilots could be anywhere from 10m above the ground to 300m over the ground at any point in the flight (subject to airspace and could be higher if the conditions allow). The data is available but I would need to do some work to find a way of getting hold of it in a suitable format. I will investigate.

2. Failing that, are you able to provide information on the preferred profiles for such flights (in the absence of airspace constraints)

Paragliders fly cross country by finding thermals to gain as much height as possible before then gliding to the next thermal. When thermalling the profile is very similar to a sailplane but a paraglider turns tighter. On glide the pilot will be descending as they cover distance. The performance of a paraglide is very poor and they only have a glide angle of between 8% and 12% downwards. They will always try to get as high as possible in the thermal subject to airspace limits. Thus the preferred profile is dependant on the weather on any particular day. I attach a klm and IGC file from a flight of mine to give you some indication of the random nature of our flights. The flight was in Wales but gives an indication about the randomness.

[3.](#) Is this based on ADSB data or similar, or is this based on GPS data direct from the pilots/aircraft?

The data has been derived from GPS data downloaded from pilots flight instruments as an "IGC" file. The flight instruments vary according to what the pilots own but the data is presented in the same format for all instruments. This is just a flat text file with GPS information recorded every second of a flight.

This data is not all of the flights as many pilots do not submit flight data to xcontest and does not include Hang Glider flights but those are much lower in numbers (about 5% of the volume of Paraglider flights).

The two screenshots show the tracks of paragliders, with the Skysurfers launch sites being easily identifiable by the intensity of the lines (Old winchester Hill, Wether Down, Butser Hill and Harting being the sites most often flown in Hampshire). Blue lines show individual flights. The airspace is marked on the screenshots and clearly show the pinchpoints around the airspace. A lot of the flights that are squeezed by the Southampton airspace are from Coombe Gibbet up to the North and by the Farnborough airspace. The biggest problem is the floor of the Farnborough airspace above our sites as this limits our operations.

There is little point in FNG communicating further with the airport as it continues to refuse to discuss the concerns we and the public have tried to raise. It is clear that the airport's FASI-S process is a tick-box exercise and it is therefore falling well short of the consultation required for such a process. A public Teams call is not an appropriate way to discuss what are technical issues that require direct engagement, discussion of evidence and several hours to present.

Several of us in FNG have conducted large public consultations using highly structured government processes and procedures under public and government scrutiny. We recognise the need for impartiality but in this case, it is being used as an excuse not to listen. The reality is that expansion in aviation fundamentally undermines the most critical issue facing this planet. These plans drive increases in GHG emissions rather than reduce them. They increase noise disturbance and pollution which are significant public health risks. We do not support any of them and the principles on which the evaluation is based are flawed.

We specifically require the process notes our objection to the poor consultation process and Farnborough Noise Group should not be listed as an organisation that has been consulted with as consultation with us has not occurred.
